Arrests and Arraignments Involving Strangulation Offenses Nov. 11, 2010 – June 30, 2012

This report provides police agencies, district attorney's offices, domestic violence advocates and the general public with the results of an analysis of arrests and arraignments involving the crime of strangulation in the 20 months since this law was enacted.

The crime of strangulation was added to the New York State Penal Law on Nov. 11, 2010, and has three offenses:

- **Criminal Obstruction of Breathing or Blood Circulation** (PL § 121.11; A Misdemeanor) criminal obstruction of breathing or blood circulation by applying pressure to the throat or neck or blocking a person's nose or mouth.
- Strangulation 2nd (PL§ 121.12; D Felony) criminal obstruction of breathing or blood circulation, as described in PL § 121.11, and causing stupor, loss of consciousness, or any other physical injury or impairment.
- **Strangulation 1st** (PL§ 121.13; C Felony) criminal obstruction of breathing or blood circulation, as described in PL § 121.11, and causing serious physical injury.

Data analyzed for this report include arrest events – charges brought at either arrest or arraignment – extracted from the DCJS Computerized Criminal History (CCH) system on June 30, 2011. The CCH captures information related to the arrests for fingerprintable offenses¹ and the subsequent processing of those cases. Information on crime victims is not available from this database.

Arrest events also include charges that were underlying more serious offenses. If a suspect had multiple strangulation charges, only the most serious charge was counted.

A total of 17,171 arrests events were reported in New York State between Nov. 11, 2010, and June 30, 2012. The majority of these were made by the New York City Police Department: 9,462 arrests, 55% of the statewide total.

Arrest Events By Month

- By March 2011, four months after enactment, law enforcement agencies were bringing these new charges on a consistent basis. Since that time, the number of arrest events in which strangulation was charged ranged between 822 and 1,090 events per month.





Figure 1. Arrests or Arraignments Involving Strangulation Offenses by Month Statewide

- Figure 1 below details the trend in strangulation offenses over 19 complete months. The light grey lines in the chart denote the quarters of each year. The law took effect on Nov. 11, 2010, which accounts for the fewer number of arrests in that month.
- For 98 cases in which the date of arrest was missing, the earliest date related to the prosecution of the case was used instead. One event was missing both an arrest date and the earliest date related to the prosecution of the case, and so is not included in Figure 1.

Arrest Events By County

- There were 20 counties that reported 150 or more strangulation arrest events between Nov. 11, 2010 and June 30, 2012.
- Of all arrest events statewide, 55% (9,472 of 17,171) were reported in New York City's five counties: Kings, Bronx, Queens, New York and Richmond.²
- The 20 counties shown in Figure 2 below accounted for 87% of all strangulation arrest events reported during this period.
- Every county except Hamilton reported at least one arrest event.

Appendix Table 1 provides a complete list of arrest events, broken down by the three Penal Law strangulation offenses, for each county in New York State.

² In New York City, all but 10 strangulation arrest events were made by the New York City Police Department. Of the 10 arrest events not reported by the NYPD, eight were reported by the New York-New Jersey Port Authority Police Department, one by the Long Beach Police Department, and the arresting agency was missing for one arrest event.

Suspect Demographics

- Gender: Males comprised 94.1% of all arrest events with a strangulation charge.
- **Race/Ethnicity:** Suspects in 45.9% of events were black, 28.8% were white, and 21.1% were Hispanic. All other suspects (including unknown or missing races) comprised 4% of the total.
- Age: Of the 17,171 suspects charged with strangulation, 41.1% were between the ages of 20 and 29; 26.2% were between the ages of 30 and 39; and 17.3% were between the ages of 40 and 49. Of all suspects, 7.2% ranged in age from 13 to 19 years old, and 8.2% were 50 years old or older. The age of one suspect was missing.

Arrest Events by Police Department

Table 2 shows 23 agencies that reported 50 or more arrest events involving strangulation offenses. These agencies accounted for 82% (14,055) of all arrest events in the state. The New York City Police Department includes all of its subdivisions and the New York State Police includes all of the agency's 10 troops across the state.



Arrests Events by Offense

- Of the 17,171 arrest events, 13,791 (80%) were for Criminal Obstruction of Breathing or Blood Circulation (PL 121.11), a class A misdemeanor.
- There were 3,168 (18%) arrest events for Strangulation 2nd (PL 121.12), a class D felony.
- There were 212 (1%) arrest events for Strangulation 1st (PL 121.13), a class C felony.
