#### **Program Overview**

The New York State Law Enforcement Agency Accreditation Program aims to provide law enforcement executives of eligible police departments and sheriffs' offices formal recognition of their compliance with 110 professional standards that focus on administration (51), operations (47), and training (12). To obtain accreditation, an agency must develop and implement policies and procedures that comply with all 110 standards.

The program standards, developed by New York State law enforcement professionals and approved by the Law Enforcement Agency Accreditation Council, are designed to enhance the effectiveness, efficiency and professionalism of an agency, promote training and foster public confidence in law enforcement. Accreditation demonstrates that the agency performs in a consistently professional manner, has formalized policies in place to govern its operational practices and procedures, and that its employees contribute to the agency's mission and know what is expected of them.

Participation in the Law Enforcement Agency Accreditation Program, established by the state in 1989, is voluntary. Executives who want their agencies to participate must submit an application and a participation agreement to the Division of Criminal Justice Services (DCJS). Once an agency has applied, policies and procedures that are aligned with the program standards must be developed. This process typically takes between six and 24 months, depending on the staff time devoted to the project and the number of policies that must be revised and/or developed to meet the program standards.

When an agency's executive is confident that the agency can adequately demonstrate compliance with every standard, an assessment is conducted. Assessments occur on-site at the law enforcement agency and are performed by three assessors who spend three days reviewing the agency's written directives and accompanying documentation, conducting interviews and making observations within the agency. If the assessors determine that the agency has demonstrated compliance with all program standards, they submit a written report detailing the specifics of the assessment to the Council, along with a recommendation that the agency be awarded accreditation.

Agencies are accredited for five years and during that time they must maintain compliance with all program standards. Maintaining compliance is determined, in part, by site visits conducted by accreditation program staff from DCJS and the agency's submission of an Annual Compliance Survey, which is a progress report intended to ensure that any lapses in compliance are immediately identified and remedied. The process is required every five years for agencies choosing to remain accredited, with reaccreditation occurring after agencies demonstrate that they have maintained compliance with the program standards.

#### **The Law Enforcement Agency Accreditation Council**

The Council is the governing body for the program as established through New York State Executive Law §846-h. The Council develops and approves program standards and adopts policies that determine how the program is administered. It also has the sole authority to award accreditation to an agency. The Law Enforcement Agency Accreditation Council meets quarterly; meeting minutes from 2020 meetings are in Appendix C.

In 2020, the Council comprised 17 members, as required by state law and nominated by the following: the New York State Association of Chiefs of Police (three); New York State Sheriffs' Association (three); the New York State Deputies Association (one); police labor organizations (two); New York State Association of Towns (one); New York State Conference of Mayors (one); New York State Association of Counties (one); the New York State Senate and Assembly (one for each); and the academic community (one). The superintendent of New York State Police and commissioner of the New York City Police Department are ex-officio members. The Governor makes all council appointments, except the ex-officio members. Enactment of the Professional Policing Act of 2021 amended the Council's composition. See Executive Law §846-h for more details.

#### **DCJS Office of Public Safety**

DCJS is the agency responsible for administering the Law Enforcement Agency Accreditation Program under Title 9 of the Official Compilation of Codes, Rules and Regulations of the State of New York, Part 6035. Members of the Accreditation Unit within the agency's Office of Public Safety administer the day-to-day activities of the program in accordance with statute and the policies set forth by the Council. They also provide a significant amount of assistance to program staff of accredited and applicant agencies.

#### **Council Support**

Accreditation Unit staff members provide all professional and administrative support to the Council. They coordinate the Council's quarterly meetings: preparing agendas, compiling information related to matters up for a vote and informing the Council about updates or potential issues with the program. Accreditation Unit staff members also review Council policies for accuracy and relevance; revise those policies when necessary; and draft new policies based on program needs.

The unit ensures that Council meetings follow the state's open meetings laws, including arranging for the video recording of meetings so they are available to the public, and preparing and distributing meeting minutes in a timely manner.

#### **Agency Support**

Accreditation Unit staff members offer technical assistance and support to agencies pursuing or maintaining accreditation by explaining the standards; aiding in program development; providing feedback on agency policies; and offering guidance on how to best demonstrate compliance with the standards. They also assist agencies in overcoming obstacles to becoming accredited and work with accredited agencies to help ensure ongoing compliance with program standards.

Unit staff members work with agency program staff to determine an agency's readiness for assessment; select assessors for each assignment; handle all logistics to ensure the agency and the assessors are prepared for the assessment; and monitor the progress of the on-site assessment. Accreditation Unit staff strive to assist every agency in being successfully accredited and in maintaining that designation.

Accreditation Unit staff members visit every accredited agency at least once during the period of accreditation. These site visits are designed to ensure agencies are maintaining compliance with the program and identify agencies that are facing challenges with compliance. When necessary,

unit staff require corrective action plans if agencies are struggling to maintain compliance and provide enhanced technical assistance so agencies can come back into compliance. Staff members conducted nine site visits in early 2020; site visits were suspended in March of that year due to the Covid-19 pandemic.

Finally, in addition to regular technical assistance, accreditation unit staff develop, coordinate and deliver training for agency program managers, command staff and program assessors.

#### Assessors

Individuals interested in becoming assessors must apply for those positions through a request for applications issued by DCJS approximately every five years, and each assessor must be vetted by unit staff and approved by the Council. Applicants must demonstrate that they have the necessary experience, either through the direct management of their agency's accreditation program, or through direct supervision of those that manage the program. Once approved by the Council, DCJS contracts with those individuals, who must attend a day-long training session prior to being considered for assignment to an assessment team. Individuals selected as assessors receive additional training by being partnered with the program's most experienced assessors during their first few assignments.

Six assessors were added to the active list in 2020, bringing the total number of assessors to 106.

#### **Program Participation**

As noted, the Law Enforcement Agency Accreditation Program is voluntary. At the end of 2020, 160 agencies were accredited, about 29 percent of the approximately 540 law enforcement agencies in the state eligible to participate. Accredited agencies in the state employ more than half of all police officers and sheriffs' deputies who work outside of New York City. The number of accredited agencies has increased annually since 2008 (see page 6 for more details).

#### **Applicant Agencies**

At the end of 2020, 33 agencies were working toward accreditation, with three of them scheduled to undergo their initial assessment in 2021. Please see Appendix A for a list of accredited agencies and Appendix B for a list of applicant agencies.

A total of 190 agencies were either accredited or actively working toward accreditation in 2020, two fewer than at the end of the previous year.

#### 2020 Program Updates

## Implementation of Versions 8.4 and 8.5 of the Standards and Compliance Verification Manual

The Council in 2020 approved two updates to the program's Standards and Compliance Verification Manual. Version 8.4 added a new critical standard, Standard 43.8 (Health of Persons in Custody). That version was superseded by Version 8.5, which included the new standard and implemented revisions to two existing ones, Standard 8.5 (Records Retention) and Standard 41.3 (Authorized Apparel, Equipment, and Identification).

Accreditation Unit staff notified all accredited agencies that they were required to be in compliance with Version 8.5 of the manual by January 1, 2021. To help ensure agencies had sufficient information to meet the new requirements by the deadline, staff compiled and distributed detailed, step-by-step guidance on policies required to be developed to meet new standards and amended to meet revised standards. In addition, staff provided guidance on the restructuring of program files to account for standards that had been consolidated into others.

Accreditation Unit staff conducted site visits to verify that agencies had successfully converted to the new standards and provided technical assistance to agencies needing additional help meeting the new requirements. Staff also added a section to the Annual Compliance Survey that addressed compliance with the new standards. Verification of compliance with Version 8.5 continues.

#### **Training**

The Accreditation Unit offered two virtual program manager trainings attended by 58 program managers, chief law enforcement officials, command staff and other agency staff, and two virtual assessor trainings attended by 38 assessors and individuals seeking to become assessors.

#### Plans for 2021

- Staff will coordinate assessments for 33 agencies with accreditation due to expire in 2021 and three agencies scheduled to be assessed for an initial accreditation (as of this report's publication date).
- Accreditation Unit staff will conduct a minimum of two program manager trainings and two assessor trainings during the year.
- Accreditation Unit staff will continue its work to expand the program by promoting the benefits of accreditation while ensuring all agencies receive the technical assistance and support necessary to become and maintain accredited status.
- Among other changes, the Professional Policing Act of 2021 requires police departments
  and sheriffs' offices to conform to minimum training and hiring standards and provides a
  mechanism for state oversight of compliance with these standards. The Council will play
  a role in ensuring compliance through certification. Staff will work with the Council to
  implement that process and ensure all program standards remain consistent with police
  reform as required by law.

#### Conclusion

The New York State Law Enforcement Agency Accreditation Program continues to be a source of great pride for the more than 19,000 law enforcement professionals employed by accredited law enforcement agencies. The Council and the Accreditation Unit are committed to the integrity and longevity of the program through continuous evaluation and enhancement to ensure that it meets the ever-changing needs of law enforcement professionals throughout New York State.

#### Remote Delivery of Program Manager and Assessors Trainings:

Mr. Marruso informed that Council that OPS has begun exploring different platforms to conduct and deliver Program Manager and Assessor Trainings Remotely. OPS staff is currently working with consultant instructors to update course materials and coordinate logistics. Accreditation Unit Staff will pilot each course for, Program Managers and Assessors, prior to September's meeting. When discussing the trainings Mr. Marruso noted that the remote course offerings will be live and interactive to allow for questions, comments and feedback.

#### **Remote Assessments:**

Mr. Marruso informed that council that in response to the ongoing pandemic and the uncertainty available resources, OPS will be temporarily updating the current procedures for on-site assessments to now include a mix of remote and on-site oversight while conducting assessments by shifting all reaccreditation assessment to Compliance Audits. Compliance Audits require only 1 person on-site for one day to conduct interviews, tour the department and assess property and evidence rooms. Compliance Audits require a minimum of 39 files, consisting of all 19 critical standards and 20 additional standards, be reviewed vs. the total 109 program standards reviewed during a typical reaccreditation assessment.

With the understanding that agencies will have many folders that are not included in their assessment, OPS staff will increase the frequency of off-site 10-file reviews as well as increase the number of files being reviewed from 10 to 30. Frequency of off-site file reviews will be increased from one file review to a minimum of two file reviews within the same 5 year timeframe. Furthermore, initial applications for accreditation typically utilize the same 3 person assessment team as reaccreditation. However, in order to ensure compliance with social distancing protocol and resource allocation, initial assessment teams will be reduced from 3 to 2 members, one of which will be a Team Leader.

On-site commitments will be restricted to the Team Leader and for one day. All 109 files will be reviewed off-site prior to the site-visit. Although we are all faced with the challenge of handling uncertainty moving forward, the integrity of the Accreditation Program remains of the utmost importance.

#### 9. Approval of New Standard

Mr. Marruso informed the Council that in response to the recently enacted police reform legislation and Executive Order 203, OPS conducted a thorough review of the accreditation program's current standards. Upon review the standards currently satisfy nearly all newly enacted legislation as well as directives provided in Executive Order 203. However, there is one addition to the standards that OPS recommends that will satisfy the New York Civil Rights Law Article 3 Section 28 which requires law enforcement to provide medical and/or mental health attention to persons in custody. The proposed new standard, "43.8 - Health of Persons in Custody," will be considered a critical standard due to the implications of non-compliance within the legislation as well as the importance of ensuring the safety and well-being of persons in law enforcement custody.

#### Removal of reference to Civil Rights Law § 50-a in Standard 25.1:

In light of the repeal of Civil Rights Law § 50-a, OPS has updated language in Standard 25.1 – Internal Affairs. Standard 25.1 sub F. previously stated, "Notifying the complainant that the matter is being handled administratively (as per §50-a of the Civil Rights Law)", however, "(as per §50-a of the Civil Rights Law)" has been removed as it is no longer relevant. After discussion the council decided to discuss further at a later date due to ongoing lawsuits calling to roll back the repeal of 50-a. Due to this no updates have been made to standard 25.1.
