Program Overview

The New York State Law Enforcement Agency Accreditation Program aims to provide law enforcement executives of eligible police departments and sheriffs' offices formal recognition of their compliance with 111 professional standards that focus on administration (51), operations (48), and training (12). To obtain accreditation, an agency must develop and implement policies and procedures that comply with all 111 standards.

The program standards, developed by New York State law enforcement professionals and approved by the Law Enforcement Agency Accreditation Council, are designed to enhance the effectiveness, efficiency and professionalism of an agency, promote training and foster public confidence in law enforcement. Accreditation demonstrates that the agency performs in a consistently professional manner, has formalized policies in place to govern its operational practices and procedures, and that its employees contribute to the agency's mission and know what is expected of them.

Participation in the Law Enforcement Agency Accreditation Program, established by the state in 1989, is voluntary. Executives who want their agencies to participate must submit an application and a participation agreement to the Division of Criminal Justice Services (DCJS). Once an agency has applied, policies and procedures that are aligned with the program standards must be developed. This process typically takes between six months to two years, depending on the staff time devoted to the project and the number of policies that must be revised and/or developed to meet the program standards.

When an agency's executive is confident that the agency can adequately demonstrate compliance with every standard, an assessment is conducted. Assessments occur on-site at the agency and are performed by three assessors who spend three days reviewing the agency's written directives and accompanying documentation, conducting interviews and making observations within the agency. If the assessors determine that the agency has demonstrated compliance with all program standards, they submit a written report detailing the specifics of the assessment to the Council, along with a recommendation that the agency be awarded accreditation.

Agencies are accredited for five years and during that time they must maintain compliance with all program standards. Maintaining compliance is determined, in part, by site visits conducted by accreditation program staff from DCJS and the agency's submission of an Annual Compliance Survey, which is a progress report intended to ensure that any lapses in compliance are immediately identified and remedied. The process occurs every five years for agencies seeking to remain accredited; the Council grants reaccreditation after agencies demonstrate that they have maintained compliance with the program standards.

The Law Enforcement Agency Accreditation Council

The Council is the governing body for the program as established through New York State Executive Law §846-h. The Council develops and approves program standards and adopts

policies that determine how the program is administered. It also has the sole authority to award accreditation to an agency. The Law Enforcement Agency Accreditation Council meets quarterly; meeting minutes from 2023 meetings are in Appendix C.

The Professional Policing Act of 2021 amended Executive Law §846-h and the Council's composition. The law requires the Council to have 19 members appointed by the Governor, with the exception of two ex-officio members: the New York State Police superintendent and the New York City Police Department commissioner.

The following organizations must nominate members for gubernatorial consideration: the New York State Association of Chiefs of Police (two); New York State Sheriffs' Association (two); the New York State Deputies Association (one); police labor organizations (two); New York State Association of Towns (one); New York State Conference of Mayors (one); New York State Association of Counties (one); the New York State Senate and Assembly (one each); and the academic community (one). The Council also must have an incumbent police chief or police commissioner from a police department consisting of more than 100 officers (one); incumbent sheriff from an agency with more than 100 deputy sheriffs (one); a representative of victims of crime (one); and a representative from a community with high numbers of police and community interactions (one).

DCJS Office of Public Safety

DCJS is the agency responsible for administering the Law Enforcement Agency Accreditation Program under Title 9 Part 6035 of the Official Compilation of Codes, Rules and Regulations of the State of New York. Members of the Accreditation Unit within the agency's Office of Public Safety administer the day-to-day activities of the program in accordance with statute and the policies set forth by the Council. They also provide a significant amount of assistance to program staff of accredited and applicant agencies.

Council Support

Accreditation Unit staff members provide all professional and administrative support to the Council. They coordinate the Council's quarterly meetings: preparing agendas, compiling information related to matters up for a vote and informing the Council about updates or potential issues with the program. Accreditation Unit staff members also review Council policies for accuracy and relevance; revise those policies when necessary; and draft new policies based on program needs.

The unit ensures that Council meetings follow the state's open meetings laws, including arranging for the video recording of meetings so they are available to the public, and preparing and distributing meeting minutes in a timely manner.

Agency Support

Accreditation Unit staff members offer technical assistance and support to agencies pursuing or maintaining accreditation by explaining the standards; aiding in program development; providing feedback on agency policies; and offering guidance on how to best demonstrate compliance with the standards. They also assist agencies in overcoming obstacles to become accredited and work with accredited agencies to help ensure ongoing compliance with program standards.

Unit staff members work with agency program staff to determine an agency's readiness for assessment; select assessors for each assignment; handle all logistics to ensure the agency and the assessors are prepared for the assessment; and monitor the progress of the on-site assessment. Accreditation Unit staff strive to assist every agency in being successfully accredited and in maintaining that designation.

Accreditation Unit staff members visit every accredited agency at least once during the period of accreditation. These site visits are designed to ensure that agencies are maintaining compliance with the program and to identify agencies that are facing challenges with compliance. When necessary, unit staff require corrective action plans for agencies that are struggling to maintain compliance, and staff will provide enhanced technical assistance so agencies can return to compliance. Staff members conducted 47 site visits in 2023.

Finally, in addition to regular technical assistance, Accreditation Unit staff develop, coordinate and deliver trainings for agency program managers, command staff and program assessors.

Assessors

Individuals interested in becoming assessors must apply for those positions through a request for applications issued by DCJS about every five years, and each assessor must be vetted by unit staff and approved by the Council. Applicants must demonstrate that they have the necessary experience, either through the direct management of their agency's accreditation program or through direct supervision of individuals who manage the program. Once approved by the Council, DCJS contracts with individuals, who must attend a day-long training session prior to being considered for assignment to an assessment team. Individuals selected as assessors also receive additional training by being partnered with the program's most experienced assessors during their first few assignments.

DCJS added nine assessors in 2023, bringing the number of active assessors to 93.

Program Participation

As noted, the Law Enforcement Agency Accreditation Program is voluntary. At the end of 2023, 174 agencies were accredited, about 33 percent of the state's 532 law enforcement agencies that are eligible to participate. Accredited agencies in the state employ nearly two-thirds of all police officers and sheriffs' deputies who work outside of New York City. The number of accredited agencies has increased annually since 2008. (Please see page 5 for additional details.)

Accredited Agency Activity in 2023

The Council awarded first-time accreditation to one agency in March, a second in June and a third during its December meeting. The Council reaccruited a total of 38 agencies at its quarterly meetings in March, June, September and December. (Please see Appendix A for a list of accredited agencies. Please see Appendix C for meeting minutes.)

Applicant Agencies

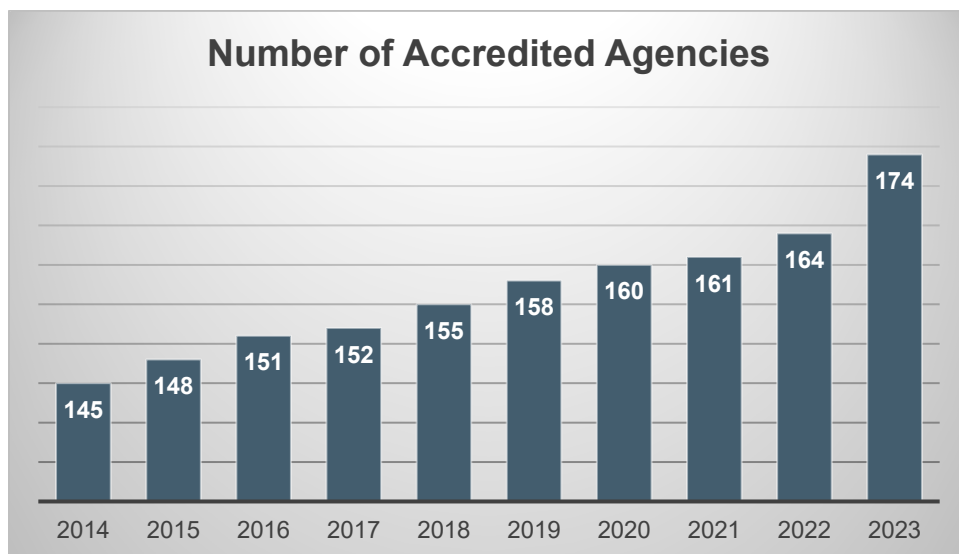
At the end of 2023, 34 agencies were working toward accreditation, with six of them scheduled to undergo their initial assessments in 2024. Applications for accreditation have increased by more than 150 percent over the previous five-year period following Executive Order 203, also known as the New York State Police Reform and Reinvention Collaborative, and the Professional Policing Act of 2021. In 2023, 208 agencies were either accredited or actively working toward accreditation.

2023 Program Updates

Implementation of the March, June and December 2023 versions of the Standards and Compliance Verification Manual

The Council approved three updates to the program's Standards and Compliance Verification Manual: a new Standard 44.4 Safeguarding Children of Arrested Parent(s)/Guardian(s); revision of Standard 43.7 In-Person Death and Major Incident Notifications; and revision of Standard 44.1 Domestic Incidents.

These changes will help agencies safeguard children, whether or not they are present when one or more of their parents or guardians are arrested; provide law enforcement personnel with the proper tools to deliver the most difficult notifications to the next of kin and/or family members; and provide agencies with guidance on recognizing, responding to, and assisting victims of domestic violence.

Accreditation Unit staff notified all accredited agencies that they were required to comply with updates to the manual within 90 days of publication. To help ensure agencies had sufficient information to meet the deadline, staff compiled and distributed detailed, step-by-step guidance on amending their policies to meet new and revised standards. Staff also provided guidance on restructuring program files to reflect the new verification strategies.

Accreditation Unit staff visited agencies to verify that agencies had successfully adopted the new standards and to provide technical assistance to agencies that needed assistance with meeting the new requirements. Verification continues, and staff added a section to the Annual Compliance Survey that included the new standards.

Mandatory Certification Process

The Council and Accreditation Unit staff developed a mandatory certification process to ensure that all police agencies conform to hiring standards prescribed by the New York State Municipal Police Training Council, as required by the Professional Policing Act of 2021. That law also requires village, town, city and county police agencies to comply with reporting requirements to the Central State Registry of Police and Peace Officers, which is administered by DCJS and to report police officer misconduct.

The mandatory certification process allows the state to oversee compliance with all required hiring and reporting standards. The law gives the Council the sole authority to certify, revoke or withhold certification, which police agencies that are covered by the law were required to obtain by October 16, 2023. An agency's failure to achieve and maintain compliance with these standards may result the Council withholding or revoking certification, which affects the agency's ability to employ police officers under state Criminal Procedure Law Section 1.20 (34).

Training

The Accreditation Unit offered three in-person program manager trainings attended by 180 program managers, chief law enforcement officials, command staff and other agency staff, as well as two in-person assessor trainings attended by 63 assessors and individuals seeking to become assessors.

Plans for 2024

- Staff will coordinate assessments of 32 agencies due to have their accreditation expire in 2024 and six agencies that are scheduled to be assessed for their first accreditation.

- Accreditation Unit staff will offer a minimum of two program manager trainings and two assessor trainings during the year.
- Accreditation Unit staff will continue to expand participation in the program by promoting the benefits of accreditation while ensuring that agencies receive the technical assistance and support necessary to achieve and maintain accredited status.
- Staff will work with the Accreditation Council to carry out the mandatory certification program; conduct assessments; and provide technical assistance and support to agencies that are required to achieve and maintain certification under the Professional Policing Act of 2021.

Conclusion

The New York State Law Enforcement Agency Accreditation Program continues to be a source of great pride for the more than 36,000 law enforcement professionals employed by accredited law enforcement agencies. The Council and the Accreditation Unit are committed to the integrity and longevity of the program, through continuous evaluation and enhancement, to ensure that it meets the ever-changing needs of law enforcement professionals throughout New York State.
