The law allows eligible individuals to petition the court to seal up to two misdemeanor convictions; one misdemeanor and one felony conviction; or one felony conviction.

This table, which will be updated annually, details the number of individuals who successfully petitioned a court to have a case(s) sealed, by year and county in which the seal was granted. If an individual has had cases sealed in multiple counties, this table lists the individual in the county and year where and when the first seal was granted.
