Twenty Professionals Trained as Workforce Development Specialists

Twenty probation officers, parole officers, community corrections practitioners and re-entry managers graduated from the most recent Workforce Development Specialist (WDS) class and received their certification in the 180-hour challenging training program. This skill-based training constitutes OPCA's WDS training; graduates will join more than 400 certified specialists who are authorized to lead individuals in groups through the 20-hour Ready, Set, Work! Program. Specialists are certified to utilize evidenced-based competencies and related skills to assist individuals with legal histories make informed decisions about jobs and career paths based on knowledge of their interests, skills/abilities, and values; educational and occupational opportunities; and the realities of the work world. The graduates are employed in a broad spectrum of agencies including Niagara County Probation, Oswego County Probation, Schenectady County Probation, County Re-entry Task Forces (Niagara and Onondaga), Oneida Workforce Development Board, SchenectadyConnects, as well as NYS DOCCS and the NYS Department of Labor. Julianna Reilly, Probation Officer from the Schenectady County Probation Department, was the Valedictorian and Stacey Lighthall, Senior Probation Officer from the Oswego County Probation Department, was the Salutatorian. Best Practice

The CRTF model is comprised of seven work plan objectives, including a requirement that new and existing staff complete the Distance Learning Modules located on the Integrated Justice Portal. These modules highlight evidence-based practices and effective interventions to use when working with justice involved individuals. Each CRTF Coordinator and staff are expected to complete the DCJS Distance Learning Modules within 6 months of contract execution or within 6 months of staff hiring date. In addition to the Distance Learning Modules, CRTF staff can access a variety of recorded training webinars either on the DCJS website or the Integrated Justice Portal.

OPCA Delivers Final Two Lunch and Learn Webinars of 2023

On May 24, more than 100 criminal justice professionals participated in the OPCA Lunch and Learn webinar titled, "Impact of Trauma on Justice Involved Individuals." One of the most important lessons learned - from studies of trauma and its impacts - is that people are resilient. People do survive, and often thrive, despite the most challenging life conditions. Professionals can help build resiliency in their clients by encouraging the individual get connected, learn coping skills, remain hopeful, be proactive, and find activities that promote selfcare, stress management and relaxation. Participants were provided a wealth of information from guest speakers and OPCA presenters on the various education and vocational resources available to the youth population in New York State. DCJS 15-City Tour Update

DCJS Commissioner Rossana Rosado and DCJS Executives have embarked on a 15-city tour to meet with local law enforcement agencies, including probation, various community corrections, reentry, and other community partners to listen and discuss the state's latest public safety and criminal justice initiatives designed to reduce violent crime and make our communities whole. Commissioner Rosado, along with members of her executive team, have been able to listen to success stories, hear about current priorities and learn about opportunities for meeting unaddressed needs. To date, the team has traveled to Rochester, Syracuse, Albany, Yonkers, Suffolk, Nassau, Buffalo, Niagara, and Mt. Vernon. The tour will continue through the summer until the middle of September, with stops in Schenectady, Troy, Poughkeepsie, Newburgh, Binghamton and Utica. Each CRTF will be invited to their respective city's meeting closer to the event dates.

Two OPCA Staff Graduate from SAMHSA's GAINS Trauma-Informed Training

In the spring of 2023, OPCA professionals Melinda Vick and Danielle Brendese attended a highly valued training and now join approximately 2,400 fellow trainers throughout the United States. Policy Research Associates, Inc., which operates SAMHSA's GAINS Center, developed a Train the Trainer (TTT) - "How Being Trauma-Informed Improves Criminal Justice Responses." This training provided information on how best to increase knowledge of what trauma is and builds a skillset for trauma-informed responses among criminal justice and behavioral health providers who serve justice involved individuals. Community corrections agencies that utilize trauma informed responses can help professionals avoid re-traumatizing individuals: increase public safety: decrease recidivism; promote and support recovery; and link individuals to trauma-informed services and treatment.
