Recently released Quarterly Report highlights CRTF activity through March 2013

A total of 2,585 individuals who returned to communities after being released from state prison were admitted into the 19 County Re-entry Task Forces during the period from Jan. 1, 2013, through March 31, 2013, according to the quarterly report issued by DCJS earlier this month. These participants have been assessed as moderate to high-risk offenders and special populations, including juveniles, females, severe medical cases, sex offenders, and maximum expiration cases. Among these participants:

- 2,537 were under Parole supervision;
- 46 served their maximum sentence and were not under Parole supervision;
- 2,397 were male, 168 were female and in 20 instances, gender was not reported;
- 12 were 17 or younger; 587 were between the ages of 18 and 24; 1,746 were between the ages of 25 and 49; and 240 were 50 years or older.

Of the CRTF participants, 1,257 received services for more than 90 days, while 377 cases were active for between 45 and 90 days. A total of 290 participants were engaged for less than 45 days.

CRTF Referral Process Change

Supervision levels, as determined by COMPAS Re-entry, will now be used to identify individuals who are Track 1 eligible. Priority is given to Supervision Levels 1 and 2, however, Level 3 cases determined to be in need of services may also be considered for Track 1. CRTF referral packets will include the COMPAS Re-entry narrative and Legacy Bar Chart, in addition to a redesigned referral form. In June, DCJS sponsored a webinar that outlined these new changes. The goal of re-entry efforts in NYS is to reduce recidivism by providing essential services that support behavioral change in those returning home from prison. CRTFs secure and case-manage services to moderate-high-risk parolees and provide access to cognitive behavioral therapies and employment services.
