Questions Submitted to DCJS through December 22, 2021 Regarding the Solicitation. Some questions may have been edited for clarity and/or to avoid duplication.

Question #1:

Will the power point of the Bidder's Conference that was held on Wednesday, December 15, 2021 be shared via email?

Answer #1:

DCJS will post the power point of the Bidder's Conference on the DCJS website at https://www.criminaljustice.ny.gov/ofpa/index.htm and will also share the recording of the Bidder's conference via email.

Question #2:

Do we need to partner with another county to submit a proposal?

Answer #2r:

Yes, applicants must be a representative of a partnership made up of at least two counties or at least one county with a non-for-profit applicant.

Question #3:

Is it an award of \$75,000 per year or a single award of \$75,000 for the duration of the project?

Answer #3:

Successful applicants will receive a single award for up to \$75,000 for duration of the contract. The contract period for this grant opportunity will be two years beginning no earlier than February 1, 2022, with an optional six-month extension.

Question #4:

If our organization is not located in an identified rural county, but we serve individuals in those counties. Can we still apply?

Answer #4:

An organization that serves individuals in an eligible rural county can apply as long as it adheres to the guidelines as stated in the RFP as follows: "Not-for-profit entities, units of local government (Including school districts) and institutions of higher learning (universities, colleges, and community colleges) who are located within the eligible counties listed, listed in Appendix: Rural Community of Practice Counties are also eligible to apply" (Section II.B).

Additionally, as stated in the RFP in Section II.B, "approaches to partnerships which include that a not-for-profit institution of higher learning could apply on behalf of the county or counties. At least one county must be a partner in the application."

Question #5:

If we use a training approach, could non-rural entities participate if the target/focus is for rural communities?

Answer #5:

If the non-rural entity can demonstrate its involvement and impact in a rural area, the entity can be included in training opportunities. The lead applicant must be one of the eligible counties listed in the Appendix of the RFP.
