The DCJS Office of Probation and Correctional Alternatives was pleased to support the Annual Conference of the NYS Probation Officers Association, which was held July 26-29 in Syracuse. More than 180 probation professionals from throughout the state attended this year's program entitled, "30 Years of Growth, Reflection and Transformation." This year marked the 30th Anniversary of the first conference. OPCA has continued to support the evidence-based training of probation professionals by providing more than thirty scholarships for conference registration. The conference presents a unique opportunity for probation officers to receive training on a multitude of current and important subjects. OPCA staff led four workshops on topics related to employment, officer wellness, the role of the Probation Supervisor, and addressing gender-based violence.

The 2023 "State Director's Award for Outstanding Service by a Probation Officer" was awarded to Cayuga County Probation Supervisor John Madden. This annual award recognizes an individual who has demonstrated exceptional service, commitment, and professionalism which has significantly contributed to the field of community corrections. Probation Quality Assurance Systems Training Held Aug 15.

On Aug. 15, more than 170 probation professionals attended the Quality Assurance Programs Webinar delivered by OPCA staff. The purpose of the webinar was to highlight for probation directors and supervisors the benefits of implementing a department quality assurance program, which ensures documented standards for work performance, personnel training, as well as the identification of areas for practice improvement. Implementation of a sound quality assurance program provides an internal system of checks and balances that encourages a culture of improvement, collaboration and supports best practice. Ultimately, it results in improved outcomes for individuals on supervision, and enhanced victim and community safety. Representatives from Westchester, Onondaga, and Monroe County probation departments shared information on their quality assurance programs and discussed strategies for working with probation officers and probation supervisors to garner support for such programs.

NYS Twelfth Annual Ignition Interlock Program Conference Held Aug 8.

On Aug. 8, OPCA convened the Twelfth Annual Ignition Interlock Program Conference in Albany at the Empire State Plaza Convention Center. The conference drew 118 individuals from 35 counties, six state agencies and all four of New York's qualified ignition interlock manufacturers. The conference included sessions on DWI Traffic Stops in NYS, US Ignition Interlock Trends, Breath Alcohol Ignition Interlock Devices, Identifying and Supervising People Convicted of DWI Offenses with Co-Occurring Mental Health Concerns, Ignition Interlock Non-Installer Enforcement, and breakout sessions with each of the manufacturers. DMV Commissioner Mark Schroeder and DCJS Deputy Commissioner Dean Defruscio, who represented Commissioner Rossana Rosado, provided welcoming remarks. Deputy Commissioner Robert Maccarone cited the program's accomplishments in recognizing more than 80,000 ignition interlock devices having been installed in the motor vehicles of



operators convicted of DWI crimes. Deputy Commissioner Maccarone shared to those in attendance how we evaluate the benefits of harm reduction and the prevention of the loss of life on New York's highways since the inception of the ignition interlock program in 2010.

Probation First Collaborative Case Work Coach Retreat

On July 11-12, OPCA hosted its inaugural Collaborative Case Work Coach Retreat. CCW coaches enjoyed a virtual workgroup with David Robinson, PhD., Orbis Partners LLC., to discuss NY-specific YASI scoring questions and Mapping A-B-C-D. OPCA Juvenile Probation Operations staff facilitated discussion on topics such as Other Required Screenings in NY's Juvenile Probation, Developing SMART Strength-Based Goals and Actions Steps, Customizing a Service Matrix, and CCW Jeopardy. The retreat included opportunities for coaches to network, share resources and exchange ideas about the design of CCW Coaching among various jurisdictions. It was a time of team building, collaboration, and transformation!



State Director Addresses Probation Departments

On July 13, State Director Robert Maccarone addressed the members of the Erie County Probation Department and on Aug. 10, he addressed the members of the Orange County Probation Department. Director Maccarone thanked the probation officers and supervisors for their extraordinary work, recognizing and appreciating just how difficult their work is and the commitment they bring to their jobs each day. Director Maccarone stressed the importance of carrying out the Order and Conditions established by the Court, but also addressed the special role probation officers have in working with individuals over extended periods of time, helping them re-evaluate their thinking and decision-making, and resulting behaviors. Officers were encouraged to never under-estimate the power of their words and the influence they have with individuals on supervision. Director Maccarone was later contacted by a probation officer who relayed that his address about the power of words and encouragement at the right time resonated deeply.



NYS DMV Registration and Title Checks

When conducting quarterly NYS DMV Registration and Title checks on individuals required to install ignition interlock devices in vehicles they "own or operate," staff should first complete a Registration Group Search. The Registration Group Search will provide a history of vehicles that an individual has registered, and the status of each registration. To verify that the individual has sold the vehicle, and not just voluntarily surrendered their plates, you should take the VIN from each vehicle and conduct a search by Vehicle ID. This will allow you to view the current title holder of the vehicle. For your reference, NYS VTL section 128 defines OWNER as follows:

A person, other than a lien holder, having the property in or title to a vehicle or vessel. The term includes a person entitled to the use and possession of a vehicle or vessel subject to a security interest in another person and also includes any lessee or bailee of a motor vehicle or vessel having the exclusive use thereof, under a lease or otherwise, for a period greater than thirty days.

OPCA Convenes Probation Focus Groups on Procedural Justice

OPCA has established an internal workgroup to develop and deliver an in-service training for probation officers on The Essentials of Procedural Justice – a course designed specifically for probation professionals. The goal of the project is to train all probation officers in New York State on the elements of procedural justice and provide promising practices and tools that staff can utilize when engaging with individuals on supervision. In July, the workgroup hosted two focus group sessions with 14 different probation departments. The focus groups were incredibly informative, and a dynamic discussion included the four pillars of procedural justice and how they are already embedded into probation practice and the best ways to deliver a training to departments across the state. Twenty Professionals Trained as Workforce Development Specialists

Twenty probation officers, parole officers, community corrections practitioners and re-entry managers graduated from the most recent Workforce Development Specialist (WDS) class and received their certification in the 180-hour challenging training program. This skill-based training constitutes OPCA's WDS training; graduates will join more than 400 certified specialists who are authorized to lead individuals in groups through the 20-hour "Ready, Set, Work!" Program. Specialists are certified to utilize evidenced-based competencies and related skills to assist individuals with legal histories make informed decisions about jobs and career paths based on knowledge of their interests, skills/abilities, and values; educational and occupational opportunities; and the realities of the world of work. Schenectady County Senior Probation Officer Julianna Reilly was the class Valedictorian and Oswego County Senior Probation Officer Stacey Lighthall was the class Salutatorian. SAMHSA's GAINS Center – How Being Trauma-Informed Improves Criminal Justice

System Responses

The prevalence of trauma among justice-involved individuals is significantly higher than the general population, which calls for a trauma-informed approach. Policy Research Associates, Inc., which operates SAMHSA's GAINS Center for Behavioral Health and Justice Transformation, developed a training to increase the knowledge of trauma and identify the skillset for trauma-informed responses by criminal justice professionals, especially community corrections agencies. On Aug. 2, certified trainers and OPCA staff Melinda Vick and Danielle Brendese delivered a virtual four-hour training to over 20 community corrections professionals. The purpose of the training was to increase probation staff understanding of trauma, create awareness on the impact of trauma on behavior and to develop trauma-informed responses and skills. Trauma-informed criminal justice responses seek to avoid retraumatizing individuals, it increases personal and community safety, reduces recidivism, and promotes the recovery of justice-involved women and men with serious mental illness. Partnerships across systems can also help to link individuals to trauma-informed services and treatment for trauma.

Interactive Journaling Training for Trainers

OPCA hosted an Interactive Journaling Training for Trainers in Albany from July 12-14. This training, delivered by Scott Covert – The Change Companies, provided an opportunity for probation professionals and other community corrections professionals to become certified trainers in the delivery of the Interactive Journaling "Courage to Change" series. The "Courage to Change" series is an evidence-based cognitive behavioral inter-



vention program that is designed to promote lasting behavioral change in the adult justiceinvolved populations. Staff that completed the training are now equipped to not only deliver the intervention directly to justice involved individuals but also train staff within their Departments or agencies in facilitating the intervention as well.

DVSI-R Training for Trainers

OPCA provided an in-person training for trainer opportunity for probation officers to become trainers in the Revised Domestic Violence Screening Instrument (DVSI-R) at the Finger Lakes Law Enforcement Academy in Canandaigua from Aug. 1-2. A total of nine probation officers from nine different probation departments completed the training and became certified DVSI-R Trainers which qualifies them to train other probation officers to utilize the specialized domestic violence screening instrument. The DVSI-R assists probation professionals with supervision decisions, improves accountability of individuals convicted of domestic violence crimes and promotes victim safety. The training was facilitated by accomplished and certified DVSI-R Trainers: Sara Mahoney, former Domestic Violence Probation Officer and current Title IX Coordinator for SUNY Geneseo, Jennifer Curry, Supervisor of the Domestic Violence Unit at Erie County Probation Department and David Lewis, Community Correction Representative, of the Training Unit at OPCA.

Currently, 38 probation departments in New York State have a DVSI-R trainer on staff and nearly 1,000 probation staff from 57 probation departments have received DVSI-R End-User training since September 2018. It is OPCA's goal to have at least one probation officer trained as a DVSI-R trainer within each department to achieve sustainability. Probation Departments that run training academies should also have at least one trainer.
