1. Raise the Age Rule Amendment Training Webinars

The DCJS Office of Probation and Correctional Alternatives (OPCA) has a series of webinars available to highlight the March 27, 2019 promulgation of probation regulations. This learning series assists probation professionals in implementing the rule amendments that have been incorporated into Parts 348, 350, 351, 352, 356 and 359 due to the implementation of the Raise the Age Law in New York State. 2. Domestic Violence Screening Instrument - Revised (DVSI-R) End-User Training Update


In September 2018, OPCA offered two courses for probation officers to become certified trainers for the Revised Domestic Violence Screening Instrument (DVSI-R). The courses were facilitated by Dr. Kirk Williams, the developer of the instrument and a professor at the Department of Criminology, Law & Society at the University of California, and Joseph DiTunno, deputy director of Family Services for the Court Support Services Division of the Connecticut State Judicial Branch. Thirty-four probation officers from 29 counties in New York State attended the training in Albany and were certified as DVSI-R trainers.

As of July 16, 2019, an additional 416 probation staff from 37 counties have received DVSI-R training from certified DVSI-R trainers. All probation staff who received end-user training are now able to utilize the DVSI-R with individuals placed on probation supervision for domestic violence-related offenses. As we move forward into 2019, OPCA aims to have at least one officer from each county across the state trained in utilizing this valuable domestic violence screening tool. The DVSI-R screening tool is available electronically through the Northpointe/NYCOMPAS suite, as well as on paper.

On June 28, 2019, OPCA, in collaboration with Senior Probation Officers and Certified DVSI-R trainers Tiffany Comeau and Thomas Bryson from Fulton County Probation Department, conducted a Regional DVSI-R Training in Fultonville (Montgomery County). The successful training included 20 probation staff from eight counties who are now qualified DVSI-R end-users.

Additionally, two Regional DVSI-R trainings are scheduled to take place in Ontario County on August 15, 2019 and Essex County in September (TBD). For more information on these trainings, see OPCA Training Updates and Schedule below.

The below map of New York State shows which county probation departments have received DVSI-R end-user training, in addition to those counties that have DVSI-R trainings planned for the near future.



Effective abusive partner intervention programs focus on offender accountability and domestic violence education while offering participants who want to change their behavior the chance to do so. Anger management curricula should never be a central component of an abusive partner intervention program. 3. Decision Points Pilot Project

From March 18 – 20, 2019, OPCA provided a 20-hour *Decision Points* facilitator training. *Decision Points* is a flexible Cognitive Behavior Intervention (CBI) that can be used in combination with other programming, or as a stand-alone program depending on a probationer's level of need. The evidenced-based training was facilitated by *Decision Points* authors Juliana Taymans, PhD and Steven Swisher M.Ed, MS, both of whom are the primary authors/developers of the well-respected *Thinking for a Change (T4C)* curriculum. The training served as New York State's pilot and included five probation departments (Dutchess, Erie, Nassau, Schenectady and Tioga), each of which had two probation officers trained as *Decision Points* facilitators, who will co-facilitate group trainings for juveniles engaged with Juvenile Probation and the Intake and Adjustment process. While *Decision Points* is being implemented as a Raise the Age initiative, the curriculum can be used for adults under supervision. OPCA encourages departments to conduct their own cognitive behavioral intervention training as they can best ensure consistency to the model and client attendance.

The Dutchess County Probation Department, for example, has already seen positive results since implementing *Decision Points* on May 1, 2019.

"Our first group was yesterday. We started with three of my toughest students at an alternative high school, as we both truly believe that this could be used with anyone regardless of the stage of change they are in. All three completed the pre-program interview prior to starting, and all three came to school and participated on the scheduled first group (5/1). They all participated and helped keep each other on task."

All pilot sites are scheduled to implement the *Decision Points* program this summer.

4. Erie County Opioid Overdose Response Project

In 2016, 301 people died from opioids in Erie County. In response, the Erie County Opiate Epidemic Task Force developed a cross-domain collaboration framework and initiated an education and prevention campaign, including naloxone distribution and training. As a result, in 2017, Erie County's opioid overdose death rate declined 17 percent. This year, the project will tackle opioid abuse in the probation population with the Probation Opioid Response Initiative. This includes utilizing a validated risk assessment tool for probationers who are at risk for opiate/opioid overdose and the institution of an Opioid Review Board to modify policy and intervention strategies with the ultimate goal of reducing overdose fatalities and opioid misuse across Erie County.

5. Westchester County Probation Officer Trainee Graduation

Westchester County Probation held its Winter 2019 Academy for new probation officer trainees. This class successfully completed eight weeks of training Fundamentals of Probation Practice (FPP), Drug Description & Testing, Field Work, First Aid, Report Writing, Defensive Tactics, Handcuffing, Initial OC, Initial Baton, Caseload Explorer, Officer Wellness and more. In April, they returned for the fourth week of FPP along with seasoned officers from Westchester, Putnam, Dutchess and Rockland counties. The Westchester POTs will return in August to complete Initial Firearms, concluding their academy training.

Dutchess County Probation Officer Kelly Milano also joined the academy and successfully completed the FFP curriculum.

6. NYS Civil Service Testing Guides – "Standard Specifications for Professional Probation Positions"

The New York State Department of Civil Service has revised the Probation Series of exams utilized by local civil service agencies to align with the new Appendix H-10, "Standard Specifications for Professional Probation Positions," effective May 28, 2019. The revised tests, which were offered in June, cover the knowledge, skills, and abilities (KSAs) that are needed by candidates when they are first hired. KSAs acquired through training are not covered in the tests because they are not needed upon appointment. A testing guide published by Civil Service for the positions of Probation Assistant, Probation Officer 1 Trainee, Probation Officer 1 is available here. Please note that Civil Service has not prepared a test guide for the other titles found in Appendix H-10. However, candidates may find helpful information in the publication "General Guide to Written Tests." This publication is available online at Test Guides and Resource Booklets.

7. Jail-Based Cognitive Behavioral Intervention (CBI) Programs Forum

On March 20, 2019, DCJS hosted a one-day forum for the 15 funded Jail-Based Cognitive Behavioral Intervention (CBI) Services Programs. The forum was held at the Alfred E. Smith State Office Building in Albany.

The forum included presentations from DCJS staff on the CBI jail-based program model, case documentation, the new operational assurance payment milestone, the fidelity initiative and lessons for operating successful programs. There was also a presentation on the Community Corrections Data Submission Application with a demonstration of how to enter required program data.

The forum included interactive discussions with programs on client engagement, program rollout, logistics and more. Staff provided a brief description of their programs, including the intake and



assessment process, CBIs utilized and jail logistics. Grantees also shared information on successes and challenges experienced to date. The information shared in the interactive discussions allowed programs to learn from each other and help DCJS provide targeted assistance to programs and their jail partners.

More than 50 people attended, including representatives from all 15 jail-based CBI programs and most of their jail partners.

8. Alternatives to Incarceration Bail Poundage Inquiry

In response to an email from a probation department regarding the 1 percent fee attached to bail money deposits, OPCA advises that Chapter 166 of the laws of 1991 established Section 99-M of the General Municipal Law. This states that an additional 1 percent fee of the amount of bail money deposited in conjunction with criminal actions shall be imposed and used to fund a local jurisdictions' alternatives to incarceration service plans approved by the then-Division of Probation and Correctional Alternatives pursuant to Article 13A of the Executive Law. These funds "shall not be used to decrease any money approved to fund the alternatives to incarceration service plan..." These funds are only to be used to *enhance or supplement* a county's Article 13A service plan.

9. Dutchess County Investment into Project MORE

According to an audit conducted by the Dutchess County Comptroller's Office, the daily cost to incarcerate a person is higher for Dutchess County than the cost to provide alternative services that may be more effective in reducing future criminal activity. According to the report, the average cost to incarcerate a person at Dutchess County Jail is \$210 per day; whereas, a person receiving aid through county programming costs between \$6.84 to \$46.04 a day.

For the past 10 years, the contract agency Project MORE Inc., has worked with the sheriff's office and the county Department of Probation and Community Corrections to provide several alternatives to incarceration that include the Transitional Housing program, the Community Transition Center, the Re-Entry, Stabilization, Transition and Reintegration Track program and the Women's Center. These programs offer a variety of services to individuals incarcerated and released from jail, including housing, anger management, employment aide and more. Comptroller Robin Lois said the report confirms there is a high success rate in the county's programs.

Onondaga County Executive Ryan McMahon visited the probation department to publicly thank and honor them for their life-saving actions.

17. Practice Tip(s)

The rules of the Interstate Commission for Adult Offender Supervision (ICAOS) have the force and effect of federal law and supersede state and local law. Recently, there have been examples of sentencing courts terminating probation sentences in lieu of New York State's responsibility to retake probationers, who have transferred their supervision through the interstate compact. This is in direct conflict with the terms of the interstate compact. *Probation Departments must inform their sentencing courts of their responsibility to issue compact warrants when necessary.* OPCA can assist any department in working with their courts to ensure compliance with the federal regulations. 18. Quick Fact

The Medical Marijuana Registry Inquiry (MMRI) is a useful tool for Law Enforcement and Probation Officers that allows officers to access the status of an individual's Medical Marijuana Card Registry. The MMRI can be accessed through eJustice under the "People" tab once the Probation Department's TAC contacts eJustice and provides a list of users to access the MMRI.
