  positions refers to the titles of Probation Officer 1 Trainee, Probation Officer 1, Probation Officer
  2/Senior Probation Officer, Probation Supervisor 1, Probation Supervisor 2/Principal Probation
  Officer, Assistant Probation Director, and Deputy Probation Director.
- 2) Probation Assistant positions may be established in a ratio of not more than one (1) for each four (4) probation officers.
- 3) For the purposes of department grouping and supervisory span of control, persons serving in the parenthetical titles of Probation Officer 1 (Community Liaison), and Probation Officer 1 (Other Language) shall be counted as Probation Officer 1 positions.
- 4) Probation Officer 2/Senior Probation Officer positions will be permitted for situations requiring officers for specialized caseloads or assignments.
- 5) Probation Supervisor 1 positions are to be established for every 4-7 probation officers (including persons serving in the titles of Probation Officer 1 Trainee, Probation Officer 1, and Probation Officer 2/Senior Probation Officer).
- 6) Probation Supervisor 2/Principal Probation Officer positions may be established in Group C & D Departments; and in Group B Departments which employ three or more Probation Supervisor 1s.
- 7) Deputy Probation Director positions are to be established in departments serving jurisdictions with a population of more than 300,000; and may be established in group C departments with a population less than 300,000, but employing 50 or more professional probation officer (PO) positions; and may be established in group B departments.
