* The number and percent of IID devices installed represents only those IIDs installed within the quarter that the operator is ordered by the court to do so, and does not depict IIDs installed subsequently, following relicensing and other common occurrences in DWI cases.

County/Agency = The monitoring authority submitting the Quarterly Report. In some counties, both monitors report on the same form.

Orders Rec'd = The number of pre-sentence/sentencing orders requiring IID installation received by the monitoring authority.

IID Class = The OPCA Class of IID that is required to be installed by the offender.

Full Pay Units = The number of devices for which the offender was ordered to pay all IID fees.

Payment Plan Units = The number of devices for which the court ordered the offender to pay a portion of the IID fees.

Cost Waived = The number of devices for which the court ordered that IID fees be waived by the manufacturer.

The total number of all Payment Types Ordered may not match the total number of IID Class 1, 2, and 3 assignments because there may be multiple vehicles on one Order.

The agencies highlighted in grey are no longer being used as CD monitors
