Approximate Video Times Dr. Dooley opened the meeting by welcoming new Chair, Dr. Michael Coble, to the New York State DNA Subcommittee. Dr. Coble acknowledged his gratitude to serve as the 00:00:00 -00:01:58 Chair and the honor it is to follow in the footsteps of Drs. Ferrara, Ballantyne, Adams, and Weir. Dr. Coble then conducted a roll call as members of the Subcommittee were in 00:01:58 attendance in New York and virtually. A quorum was established with 6 members present 00:02:35 (Bieber, Coble, Corrado, Gettings, Kidd, Sozer). Dr. Coble then asked for a motion to approve the August 4, 2023, agenda. A motion 00:02:38 -00:03:20 to approve the agenda was made by Dr. Sozer, seconded by Dr. Kidd, and approved unanimously. The Chair then asked Subcommittee members for questions or comments on the 00.03.22 -00:04:30 minutes from the May 12, 2023, meeting of the Subcommittee. Dr. Corrado made a motion to approve the minutes, seconded by Dr. Gettings, and approved with four votes (Bieber, Corrado, Gettings, Sozer) and 2 abstentions (Coble and Kidd). Next, the Subcommittee reviewed Accreditation/Laboratory updates from the Erie 00:04:33-County Central Police Services Forensic Laboratory, Monroe County Crime Laboratory, New 00:07:49 York State Police Crime Laboratory and the Westchester County Department of Laboratories and Research Division of Forensic Science. Representatives from the laboratories were available to answer questions as needed. The Chair then moved to Old Business. A verbal update was provided by Dr. Dooley 00.07.51 on the Partial Match and Familial Search programs. The Familial Search program remains 00.16.28 paused, awaiting a hearing of the appeal scheduled for September 14, 2023. There were no current CODIS bulletins; however, it is anticipated that by the end of August there will be a bulletin regarding an issue with the mitochondrial DNA CODIS PopStats. The Subcommittee then reviewed disclosures from the New York State Police Crime 00:16:31 -Laboratory and New York City OCME, Department of Forensic Biology. Representatives from 00:21:57 the laboratories were available to respond to members' questions. Dr. Coble requested a motion to enter Executive Session to discuss matters relating 00:21:59 to a current investigation or matters that may lead to the appointment, promotion, demotion, 00:22:53
